PROCEEDINGS OF THE FRANKLIN COUNTY BOARD OF SUPERVISORS

MARCH 8TH, 2021

Be it duly noted that these minutes are UNOFFICIAL.
The Board of Supervisors met at 8:30AM at the Franklin County Courthouse with Board members Michael Nolte, Gary, Chris Vanness present.
Chairman Nolte led the Pledge of Allegiance.
Motion by Vanness, Seconded by McVicker to approve the Agenda as presented. All ayes. Motion carried.

Motion by Vanness, Seconded by McVicker to approve the Board Minutes and Drainage Minutes dated 3/1/21. All ayes. Motion carried.

Public Comment & Board Committee Reports: Supervisor Vanness attended an orientation for North Iowa Community Action. Gary attended a training via Zoom for Workforce Development.

Jay Waddingham, County Engineer met with the Board regarding various items. He gave an update on the construction of the Popejoy shed. Crews have been working on brush clean-up and tree removal around the county. Motion by McVicker, Seconded by Vanness to approve Franklin County Utility Permit Application for Woolstock Mutual Telephone to construct fiber from Lark Ave along 170th Street to Heather Ave and City of Latimer; City of Latimer and Grouse Ave to 160th Street from Grouse Ave to Balsam Ave (S14) from 160th St to Highway 3. All ayes. Motion carried. Motion by McVicker, Seconded by Vanness to approve concurrence with Iowa DOT Permits for fiber installation at I-35 and 160th Street and Hwy 3 at Balsam Ave and Wright Ave for Woolstock Mutual Telephone to install fiber optics. All ayes. Motion carried. Supervisor Nolte signed the contract with Weidemann Inc for Quail Ave RCB Box, L-10-116-(1)-73-35.

Sheriff Aaron Dodd gave the Board an update about his department.
Ashley Roberts, Public Health Director, also updated the board about her department including where things stand with the COVID-19 vaccination. The supervisors asked her opinion about the current mask mandate in county facilities. She recommended leaving the policy as is for a while longer.

The board attended a joint Drainage Meeting with Cerro Gordo County for approval of assessments. Full details are available in the Drainage Minutes.
Lee Galentine, CGA, Drainage Engineer, attended to discuss several work orders. Full details are available in the Drainage Minutes.

The Human Resource Director, Audrey Emery, presented the board with a proposal to implement an electronic timecard program. This will be web-based and have other features that the department heads and employees will be able to utilize. She stated that the use of the program will help Human Resources process payroll in less time and with more accuracy. Motion by Vanness, Seconded by McVicker to approve moving forward with RT Vision for electronic timecards. All ayes. Motion carried. There was discussion regarding the expiring Sheriff's Contract items. Emery will work with Sheriff Dodd to finalize proposals.

The Board canvassed the votes from the Iowa Falls CSD and Clarion-Goldfield-Dows CSD Special Elections held on 3/2/21. Motion by Vanness, Seconded by McVicker to approve the Clarion-Goldfield-Dows CSD Special Election results. All ayes. Motion carried. Motion by McVicker, Seconded by Vanness motioned to approve the Iowa Falls CSD Special Election results. All ayes. Motion carried.

Motion by McVicker, Seconded by Vanness to approve the claims as presented. All ayes. Motion carried.

The Board acknowledged the Sheriff's Monthly Report.
Motion by Vanness, Seconded by McVicker to adjourn at 12:15PM until March 15th, 2021 at 8:30AM at the Franklin County Courthouse. All ayes. Motion carried.
