The Thornton City Council met on the above date and time with Mayor Mike Jensen calling the meeting to order. Council members present: Joe Colman, Randy Bohman, Larry Stadlander, Roger Engebretson, and Michael Hopkey. Also present: City Attorney Mike Moeller, Koty Kuhlers, Tom Janeka, Tom Meyer, John Robbins, and Dick Fridley.

Hopkey made a motion to approve an addition of a discussion about the Reysack property. Bohman seconded, motion carried.

Hopkey made a motion to approve the consent agenda with the addition. Stadlander seconded, motion carried.

Jensen opened the public hearing for the budget amendment for fiscal year ending 6/30/2021. There were no written, oral, or public objections. Bohman made a motion to close the public hearing. Hopkey seconded, roll call vote was unanimous, motion carried. Stadlander made a motion to approve the budget amendment. Bohman seconded, unanimous roll call vote, motion carried.

Hopkey made a motion to amend the previous decision on the purchasing of a flagpole. Stadlander seconded, motion carried. There will be a telescopic flagpole purchased.

Reminder that community clean up day is June 7, 2021.

Discussion on the zoning board decision about the change in use for a property the County purchased was had. The zoning board gave a recommendation to accept the request from the County. Hopkey made a motion to accept the recommendation from the board and approve the building permit from the County. Colman seconded, unanimous roll call vote, motion carried.

The request for purchasing 4 new dumpsters was tabled.

There was discussion on getting paperwork ready for the Reysack property. Hopkey made a motion to approve a memorandum to share the cost of cleaning up the property and allowing Jensen and Hobscheidt to sign any and all things regarding this. Engebretson seconded, motion approved.

Engebretson made a motion to adjourn. Hopkey seconded, motion carried.
