Voter Accessibility: Each polling place is accessible to persons with physical disabilities and has a ballot mark-

ing machine that allows a voter with blindness or visual impairment to vote privately. A voter may choose a person to assist them in voting except the voter's employer, employer's agent, an officer or agent of the voter's union, or a candidate on the ballot. Any voter who is physically unable to enter a polling place has the right to vote in their Auditor's Office Hours: The Auditor's Office will be open Saturday, June 4th from 8:00 am until 5:00 pm for absentee voting. Normal office hours are 8:00 am to 4:30 pm Monday-Friday. Absentee voting in the Auditor's Office
