PROCEEDINGS OF THE FRANKLIN COUNTY BOARD OF SUPERVISORS
JUNE 6TH, 2022

The Board of Supervisors met at 8:30AM on Monday, June 6th, 2022, at the Franklin County Courthouse with Board members McVicker, Nolte, & Vanness in attendance.

Chairman McVicker led the Pledge of Allegiance.

Motion by Vanness, seconded by Nolte to approve the Agenda as presented. All ayes. Motion carried. Motion by Vanness, seconded by McVicker to approve the Board Minutes from the regular meeting dated 5/31/22. All ayes. Motion carried.

Public Comment & Board Committee Updates: Nolte attended Access. Vanness attended Conservation. Cory Eberling from Indigo Wind was present and introduced a land agent working in the area.

Jay Waddingham, County Engineer met with the Board and gave an update on his department.

Motion by Nolte, seconded by Vanness to approve a resolution Setting a Public Hearing Disposing of Franklin County Owned Property in Chapin. The resolution reads in full:

A RESOLUTION SETTING A

PUBLIC HEARING ON THE BOARD OF SUPERVISORS INTENT TO CAUSE THE PROPERTIES OWNED BY FRANKLIN COUNTY LOCATED IN CHAPIN TO BE DISPOSED.

WHEREAS, Code of Iowa 331.361.2(a) requires the Board to set forth in a resolution its proposal to dispose of public property, and publish notice of the time and place of the public hearing on the proposal, in accordance with the Code of Iowa §331.305, and

WHEREAS, after the public hearing, the Board may take a final determination on the proposal by resolution. NOW, THEREFORE LET IT BE RESOLVED that a public hearing be set at 10:15AM Monday, June 27th, 2022 in the Board Room, Franklin County Courthouse, Hampton, Iowa and LET IT BE FURTHER RESOLVED, that the proposed method for disposal for the property located at: Alley East of Lots 89 to 119, Beeds Addition to Chapin Station, Iowa. Will be by sealed bids with the option by bidders to raise bids for the alley on July 5th, 2022 at 9:45AM in the Supervisors Chambers of the Franklin County Courthouse. BE IT RESOLVED that the Franklin County Board of Supervisors approves the disposal.

Roll call vote was as follows, Ayes: McVicker, Nolte, Vanness. Motion carried and resolution duly adopted.

Motion by Nolte, seconded by Vanness to approve the Closure of Warbler Avenue between 60th Street and 75th Street due to Culvert Construction Repair as of 6/2/2022 at 2:15PM. All ayes. Motion carried.

Motion by Vanness, seconded by Nolte to open the public hearing pertaining a FY22 Budget Amendment. All ayes. Motion carried. The Auditor reviewed the amendment with the Board. There was no comment from the public. Motion by Nolte, seconded by Vanness to close the public hearing at 9:32AM. All ayes. Motion carried.

Motion by Vanness, seconded by Nolte to approve a resolution amending the FY22 budget. The resolution reads in full:
